Notice is hereby given that the resolution set out below is proposed to be passed by the members of P.H. The Scrutinizer's decision on the validity of the Postal Ballot shall be final.

The Company has engaged the services of Central Depository Services (India) Limited ("CDSL) as the agency to provide e-voting facility.

In accordance with the MCA Circulars, members can vote only through the remote e-voting process. Accordingly, the Company is pleased to provide remote e-voting facility to all its members to cast their votes electronically. - (i) The voting period begins on 9:00 a.m. (IST) on Monday, February 28, 2022 and ends on 5:00 p.m. (IST) on Tuesday, March 29, 2022. During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of Friday, February 18, 2022 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote evoting facility to its shareholders, in respect of all shareholders' resolutions.

The remote e-voting will not be allowed beyond the aforesaid date and time and the remote e-voting module shall be forthwith disabled by CDSL upon expiry of the aforesaid period.

Considering the rich and varied experiences in the investment advisory industry, his association & participation in day to day affairs & management of the Company as well as the progress made & milestones achieved by the Company under the guidance and supervision of Mr. Rikeen Dalal, the Nomination and Remuneration Committee has recommended, and the Board has approved the revision of remuneration of Mr. Dalal from Rs. 20,000/- per month (including basic salary, allowances, and perquisites) to an amount upto Rs. 10,00,000/- per month (including basic salary, allowances, and perquisites) with effect from January 01, 2022 till the end of remaining duration of his existing tenure i.e. up to November 10, 2022 and all the existing terms and condition of his appointment as contained in the resolution passed at 47th AGM shall remain in full force and effect.

In terms of pursuant to provisions of Section 196, 197, 198 and 203 read with Schedule V to the extent applicable and all other applicable provisions along with rules made there under, if any, of the Companies Act, 2013 (including any statutory modification(s) or re-enactment(s) thereof for the time being in force), payment of remuneration requires approval of Members of the Company in form of Special Resolution. Hence, the Members are requested to pass the Special Resolutions accordingly.


